Press Note

Chief Electoral Officer, West Bengal along with Addl. CEOs, Jt. CEOs, Dy. CEO conducted a Co-ordination meeting today at Williamson Magor Hall of the Bengal Chamber of Commerce and Industry with more than 22 Enforcement agencies. (List enclosed)

As per the directive of ECI, a meeting with the enforcement agencies is to be held before six months of last day of the electoral process. So this meeting was held today (11th December). The participating departments have been instructed to appoint nodal officers, take measures to start control room to be set up from the date of Press note by ECI as a part of pre-notification activity.

Direction was issued by the CEO West Bengal to all the departments present to coordinate and share information among themselves and send the election related inputs to this end. It was clarified that after notification, there will be CCTV coverage and webcasting at all Naka points with the SST. There will be GPS tracked Flying Squad vehicles with camera mounted on them for webcasting. All the departments were requested to plan in this line.

It was also decided that the departments will collate the data of critical areas within their jurisdiction with inputs from the districts, to be received next month from the DEO Level meeting with the district nodal Officers. The Agencies will share the organogram of their activities. The final list of expenditure Sensitive Constituencies will be prepared at the level of

CEO WB with all these inputs. Next meeting will be held after two months to review the progress.

Chief Electoral Officer, West Bengal stressed on the point of uniform functioning of all the enforcement agencies with the target of a free, fair and inducement free election in the coming year.
